

# ACTION PLAN TO COUNTER RADICAL IDEOLOGICAL/RELIGIOUS FUNDAMENTALIST TERRORISM

## SUMMARY AND BACKGROUND

*Differentiate Moderate Muslims and Fundamentalists:* There are many Muslims who are very good and fine people that are loyal to the United States and our traditions of diversity, freedom of religion, and traditional values fought and bled for during 232 years of development and evolution. It is recognized that there are secular, traditional and fundamentalist Muslims. However, the voices of the secular and traditional Muslims must be heard to denounce the political ideology and the goals of the fundamentalists who still appropriate as current a doctrine written 1300 years ago and full of violence and hatred. It is very mystifying as to why the “moderates” refuse to condemn the terrorists. Are they fearful for their lives as well as those of their families because they might also be called “apostates” (those who leave Islam) which means they are subject to death? We must embrace their desire to practice their religion (which has shared values of virtue and morality) as a protected institution as long as they endorse American rule of law, our Constitution, religious tolerance and minority and women’s rights and denounce sharia law. We ask loyal fellow American Muslims to help us root out the terrorists and fifth columnists in our country. We desire to be protected from overt and covert attacks not only from violent attacks but also from political activities by the fundamentalists. These action recommendations relate to awareness and political and security actions to protect our freedoms from encroachments and threats and influences of radical fundamentalists worldwide who are on the move especially in our country to undermine the United States of America. If there are adherents or institutions upholding any ideology (such as sharia law) who are not loyal to the constitutional republic of the United States, then let them be aware that just as the Japanese admiral said after the attack was launched on Pearl Harbor “I am afraid we have awakened a sleeping giant”, let this giant of our citizenry wake up before it is too late.

*We are in a Long War:* Become informed of the historical consistency of institutional religious fundamentalism as a triumphalistic ideology fixed upon world domination by force and establishment of a worldwide caliphate. Our culture and our civilization can be considered in a “Long War” that started in 1979 with the taking of the hostages at our embassy in Iran. This is a serious national and free world security threat. We have been lulled to sleep that the armed radical jihadists such as Al Qaeda are the only threat. This is not true. There is a very well-thought out movement in our country to subvert our

culture with the belief that religious fundamentalism as propagated by Wahhabism is peaceful. It is not. We need to distinguish religious custom, traditions and practices from the political agenda of religious fundamentalists. The “political” Islamic jihadists in our land who wish to overcome our way of life through demographic and political non-violent methods are also in the long run as inimical to our freedoms as those who desire to plot explosions to destroy us. They are hiding their ideology (a combined church/state theocracy) behind a façade of what they propagate as only a religious faith to take advantage of our tolerance for religious institutions. We are awash in propagators who have bought their “peaceful and tolerant” propaganda and quote the beginning parts of the Quran ignoring the latter parts heavy on jihad in its violent forms.

Within our government, where there are instances of political correctness blinding us to reality of the threat from potentially disloyal employees, we must be wise and recognize these threats and terminate employees whose preeminent loyalty is not to the United States.

## **LOCAL ACTION**

### Visit Mosques

- Invite your pastors and other interested citizens to visit local imams at their mosques.

Ask them the following:

To which sect of Islam do they belong? Sufi? Shia? Sunni?

Where did they receive their scholarly training? If Saudi Arabia, Pakistan, or Egypt, a red flag should go up.

- Where were they born? Are they Wahhabists?
- Did any foreign entity contribute to their mosque construction? Is their deed held by the North American Islamic Trust (NAIT), supposedly a Saudi-backed front for the radical Muslim Brotherhood?
- What is their belief in upholding American constitutional law versus sharia law? Are earlier or later Quranic revelations what a Muslim is to follow?
- How do they define “jihad”?
- What are their beliefs on Islamic apostasy (converting from Islam), blasphemy, political Islam, religious freedom, domestic violence, polygamy?
- Are they acquainted with the 1980 publication of the Islamic Council of Europe titled “Muslim Communities in Non-Muslim States” which explains the Muslim agenda in Europe?

For most Americans, religious tolerance under the first amendment is a sacred cow, and would rank more highly than even political correctness. However, it is important that any system which seeks to overthrow our constitution through jihad is seditious. Sedition trumps freedom of religion if that religion seeks to displace all other religions and our secular system of government with Islam by political subversion and/or force.

If you are not satisfied with the answers of the imams as to their loyalty, write your congressman and senators to consider expulsion of any imams who are not loyal to the United States and preach disloyalty or religious intolerance and shut down their mosques.

The key question is “Do Islamic proselytes have the right to call others to their faith in the West, even as they espouse an ideology that would refuse this right to others?”

#### Construction of New Mosques

Why should the Saudi Arabian government fund mosques in the United states when Jews and Christians cannot even practice their faith in Saudi Arabia much less build a worship structure?

#### **NEWSPAPERS**

Ask your local newspaper to publish on the front page a daily atrocity committed anywhere in the world by jihadist terrorists/religious fundamentalists.

#### **SOCIAL**

##### Charities/ Lobbying Groups

The threat from the charities which support terrorists is not over. Support our justice system to keep the pressure on them. Write to Islamic lobbying groups and ask them for copies of their contributions. The IRS should ask them to certify they do not promote “separatism, terrorism, or violence”.

##### **SCHOOLS:** (write local school superintendents)

Ensure that in the public school in your community that there is no special privilege afforded such as Muslim prayer time, etc. If there are any private Islamic or Middle-Eastern-funded schools in your community, confirm that their textbooks and teachings do not include intolerant and violent references or militant religious teachings. If you find violations, contact the United States Commission on International Religious Freedoms. (202-523-3240).

Examine the Social Studies textbooks in Islamic schools as to how they educate their students about religious tolerance, Islam, “jihadism”, secular law, and minority and women’s rights. Is the Council on Islamic Education (CIE) and/or any CIE scholar or former Saudi employee, cited as a consultant?

If you determine that a school is teaching intolerance and it is funded by foreign countries write the ambassador in Washington, D. C. of that country.

Consideration should be given to a law that prohibits foreign funding, direct or indirect, of US religious institutions and schools by the government or citizens of any state that denies religious freedom to its own residents. If a country denies churches or synagogues in its country, no “madrasahs” should be allowed in America.

### **UNIVERSITIES AND COLLEGES (PUBLIC AND PRIVATE)**

#### Background

- Middle Eastern countries profiting from U. S. petrodollars have spent billions of dollars since the 1970’s to influence education programs in the United States. Typically they are established by donations to create Middle East/Islamic Studies Centers. Naturally the curriculum taught and students are oriented to adopt the thought of the contributors. Muslim student organizations are proliferating under the banner of the Muslim Student Association (MSA), which was supposedly founded by members of the radical Muslim Brotherhood. Ask to see their mission statements in English and Arabic. Consideration should be given to a law requiring every think tank or College that accepts money from foreign governments, overseas institutions or ruling-dynasty parties to register as lobbyists.
- Write the presidents of local universities and colleges and determine if they have centers for Middle Eastern/Islamic studies as to how are they funded (Saudi Arabia?), and obtain mission statements.
- When an academic institution in your community establishes one of these study centers, find out who are the biggest contributors or trustees of the school and ask them to do an independent

investigation and analysis of what is being taught there. Ask those people to examine the textbooks.

- Any academicians who are employed by Islamic Centers should be asked to declare their loyalty ( to the political parts of the Quran or to the U.S.). When we read articles that attempt to downplay the radical fundamentalist game plan, ask the writers who is paying their salaries and ask to see their contribution reports and determine from where their contributions come if they are employed by organizations and foundations. Concentrate on foreign monies supporting their entities.

### **STOCKHOLDERS**

Review the annual reports of any U.S. companies in which you own stock and at stockholder meetings ask about “Sharia-compliant” business practices. Ask if the company intends to make contributions to Islamic “charities”.

### **NATIONAL**

(Pick an issue a week and communicate with your member of congress)

- It is a given that we must support efforts to achieve alternate sources of energy so that we can stop paying so much to countries who use the petrodollars to undermine our culture. We must in the words of Newt Gingrich (11/15/07) “...move to a hydrogen economy and to eliminate petroleum as primary source of energy.”
- Call for a congressional inquiry to establish whether Islam as practiced in the United States is a religion or a system for political ideology to be established under Sharia law to replace our constitution. Ask for an official inquiry into the purposes of the national Islamic lobbying organizations in our country, such as the Council on American-Islamic Relations(CAIR) and the Islamic Society of North America(ISNA), both recently named by federal prosecutors as unindicted co-conspirators in a terror plot to funnel more than \$12 million to Hamas suicide bombers and their families..

### **NATIONAL SECURITY**

- Given that our current war is against Islamist fundamentalist triumphalism, we need to be sure that all employees involved in our government (Department of Defense, State, CIA, Homeland Security, military and prison chaplaincy) are loyal to the United States above the teachings of radical religious leaders.
- We need to hire only Arabic, Pushtan and Farsi translators in our intelligence and FBI services whom we can trust. Our national security comes first! We must resist pressures and hire our interpreters from any group internationally that is loyal assuredly to our country.
- Ask your elected officials to support a policy: “When we offer immigrant or visa status to foreigners, ask them on their applications to confirm or deny membership in any organization designated as a terrorist organization. Require specific denoting of membership in any foreign-originated organizations such as the Muslim Brotherhood. Specify all terrorist organizations on the forms”. This is especially important for student visas for any students from the 34 countries designated by Homeland Security as “countries of interest for terrorism”.  
(See [www.state.gov](http://www.state.gov)) search, “Foreign Terrorist Organizations.”

Require new immigrants to give up dual citizenship, give up former country passports, pledge allegiance to the United States, and register for Selective Service.

- Write your congressman to work to adopt the Protect America Act and strengthen the Foreign Intelligence Surveillance Act, and the Terrorist Surveillance Program (TSP). Ask our national elected officials to create a safety board and commissioner to study and examine the dangers of Islamic dogma in our society.
- Ask your national elected officials to be constantly cognizant of appeasement of political fundamentalists hiding behind religious rights and expressions of “political correctness”. Recognize that if elected officials have large Muslim constituencies that they will be politically tolerant of all these issues of the radicals. Legislation should be considered that prohibits speech that advocates violence, mayhem, and murder.

- As in free trade, we need to put up barriers against nations who do not reciprocate religious tolerance. Given that Islamic states prohibit Jews and Christians from practicing their faith openly, we should likewise close mosques whose teaching is seditious. Certainly a wise first step would be to disallow Wahhabi clerics from Saudi Arabia from operating within our borders specifically by restricting R-1 visas.
- Recognize that Iran is bent on our destruction and is assisting in the killing of our young warriors in Iraq. Keep the pressure on Iran and continue to consider military action against the country despite the NIE report of Dec. 2007. Perhaps we should use our navy to stop transport of their oil from their country and cut them off economically.

### **IMMIGRANTS**

According to M. Zuhdi Jasser, founder and Chairman of the American Islamic Forum for Democracy ([www.aifdemocracy.org](http://www.aifdemocracy.org)) in a paper on January 24, 2008 these are some ideas for our Muslim immigrants who enjoy the freedoms and liberty of their home in the United States.

- A. Help move their own former homelands to the freedoms they enjoy here.
- B. Urge their imams in American mosques to denounce corruption and fundamentalists.
- C. Establish non-profit think tanks, advocacy groups, and watch groups to counter the lack of enlightenment and liberty so prevalent all over the world in countries controlled by radical clerics and violent jihadists.
- D. Advocate a spiritual moral Islam free of political agendas that move countries toward Islamic Republicanism.

Formulate a fatwah condemning –by name— Hamas and Hezbollah and other terror groups, and also a separate fatwah condemning Osama bin Laden as an apostate (if indeed he is perverting a peaceful religion).
